6. Award of contract

- 6.1 Notwithstanding the above, the Purchaser reserves the right to accept or reject any quotations and to cancel the bidding process and reject all quotations at any time prior to the award of contract.
- 6.2 The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the supply order.
- 7. Payment shall be made within 45 days after delivery/ acceptance of the goods. / or completion work
- 8. Delivery will be within 30 days after receiving the Purchase Order. (Installations and completion of the services within 60 Days after Delivery Of the material.)
- 9. **Delays in the Supplier's Performance:** Delivery of the Goods and performance of related Services shall be made by the Supplier in accordance with the time schedule prescribed by the Purchaser in the Purchase Orders. If at any time during performance of the Purchase Order, the Supplier should encounter conditions impeding timely delivery of the Goods and performance of Services, the Supplier shall promptly notify the Purchaser in writing of the fact of the delay, it's likely duration, and its cause(s). As soon as practicable after receipt of the Supplier 's notice, the Purchaser shall evaluate the situation and may at its discretion extend the Supplier 's time for performance, with or without liquidated damages, in which case the extension shall be ratified by the parties by amendment of the Purchase Order.
- 10. **Liquidated Damages for Delay:** If the Supplier fails to deliver any or all of the Goods or to perform the Services within the period(s) specified in the Purchase Order, the Purchaser shall deduct from the Purchase Order Price, as liquidated damages, a sum equivalent to 0.5% of price of the delayed Goods or unperformed Services for each week or part thereof of delay until actual delivery or performance, up to a maximum deduction of the I0% of the Purchase Order price. Once the maximum is reached, the Purchaser may consider termination of the Agreement or the Purchase Order.
- 11. **Taxes and Duties:** The Supplier shall be entirely responsible for all taxes, duties, etc. incurred until delivery of the contracted Goods to the Purchaser.
- 12. Purchaser will carry out commercial evaluation item basis. Lowest quote per item will be considered. However, Purchaser may evaluate the entire bid considering the supply as Single lot.
